

TERMS & CONDITIONS

General terms and conditions of the prize game “Win nMETOS 100” apply to the prize game, owned and operated by Pessl Instruments GmbH, and available only for visitors of EIMA 2024.

GENERAL PROVISIONS

The organizer of the prize game is Pessl Instruments GmbH, Werksweg 107, 8160 Weiz, Austria (hereinafter the organizer).

PARTICIPATION CONDITIONS

Participation is open to EIMA 2024 visitors. Participation in the prize game is not conditional.

The participants of the prize game shall themselves bear all the costs of participation in the prize game. Cooperation costs include, but are not limited to: the cost of Internet access and the cost of downloading data from the Internet.

Employees and external contractors of Pessl Instruments GmbH or their immediate family members may not participate in the prize competition.

PRIZE GAME RULES

The prize game is available only to EIMA 2024 visitors, who enter the competition by filling out the contact form at the Booth of METOS® by Pessl Instruments (Hall 37, Stand A/48).

By submitting their email, participants agree that Pessl Instruments may send him/her/them promotional e-mail messages with updates, news, latest blog posts, event invitations, and other similar messages. They understand and agree that Pessl Instruments may use their information in accordance with its Privacy Policy.

In the event of incomplete, incorrect, or untrue information, the organizer reserves the right to refuse or exclude the participant from the prize game. The participant loses the right to the prize if the organizer determines that: the participant did not meet the conditions for participation; the participant violated the rules and conditions of participation in the prize game; the participant does not wish to fulfill the obligations in accordance with these terms or special conditions, or did not fulfill them in due time; in the case of applications: if the application is in any way inappropriate. In case the participant loses the right to the prize, the organizer decides whether or not to award the prize to someone else.

PRIZES

A code for METOS® VWS will be sent to the email address of a participant added to the contact form on the website "<https://metos.global/eima-2024-prize>" no later than 7 days prior to the entry to the prize draw.

PRIZE DRAW

The organization, implementation, and control of the running of the prize draw and the prize draw shall be taken care of by a committee composed of representatives of the organizer. The prize draw will take place on November 13th, 2024.

The prize winner will receive the prize notice via his/her/their e-mail address, which he/she/they provided at the beginning of the prize draw or in a manner previously determined. By participating in an individual prize game, the participant agrees that, in the event of a draw, the organizer will publish the winner on the organizer's website and/or organizers' social media channels. The list of winners will be published no later than three days after the prize draw. The results of the prize draw are final. It is not possible to appeal to them.

RECEIVING PRIZES

A participant is entitled to receive the prize if he/she/they are notified by the organizer within the agreed deadline. Persons under the age of 18 must submit the written consent of the parent or legal guardian to the organizer in order to accept the prize, no later than before accepting the prize. Written consent can be formed by the parents or legal guardians themselves.

PERSONAL DATA AND INFORMATION PROTECTION

The organizer as the controller of personal data respects the privacy of participants of this prize game and undertakes to treat and protect personal data obtained during the prize game carefully and to protect and process them in accordance with the Personal Data Protection Act.

Without the explicit consent of the participants of individual prize games, the organizer will not share the participants' personal data with a third party or use them for other purposes than solely for the successful overall performance of the prize game.

The organizer assumes no responsibility for the protection of the data on the web pages to which certain links on the organizer's websites lead, nor does it accept any responsibility for any errors that may occur when the participants of the prize game provide false or fake information.
